It is a legal requirement for contractors to make a Construction Industry Scheme (CIS) Monthly Return to HM Revenue & Customs (HMRC) showing all payments made to sub-contractors. MYOB Payroll includes the new CIS management reporting requirements and will produce the information required to produce the CIS Monthly Return.

Make payday stress free

MYOB Payroll calculates and manages your business payroll to the HMRC approved Payroll Standard. All you need to do is enter the details of your business and of each employee, and each time you pay your employees the software will produce the following:

- Payslip for each employee
- Report detailing the amount you should send to HMRC for the period

Multi-company payroll programs

MYOB Payroll has been specifically developed to be easily accessible to PAYE novices, whilst simultaneously fulfilling the more demanding requirements of professional users such as accountants and payroll services providers.

For users with a multi-company licence, an import/export feature allows accountants and clients to share data and backed-up files can be easily imported and modified whenever necessary. The amount of businesses MYOB Payroll processes can be simply increased by keying in a registration PIN number. The upper limit for this is currently 100 businesses. Editions of MYOB Payroll covering different tax years can be installed concurrently. In addition to the end of year filing, MYOB Payroll also caters for sending (not receiving) starter and leaver information.

Internet Filing for new starter and leaver information:

- P45(1), P45(3), P46 documents can be sent to HMRC
- HMRC accreditation gained for these in-year transactions
- Additional tab on the employee file maintenance to control data for the P45/P46 data
